Position: BASC Goal Keeper Trainer 2018

Bid Process



CONTRACTED SERVICES

Client Representative:

The Goal Keeper Trainer shall report to the CLIENT's representative the BASC Head Coach.

CONTRACTOR's Operational Duties & Responsibilities:

- Must have at least one of the following requirements:
 - United Soccer Coaches (formerly NSCAA) Level 1, 2, or 3 GK diploma
 - USSF National D license or NSCAA equivalent
 - USSF Goalkeeper license
 - Or verifiable playing time experience at the collegiate or professional level
- Instruct, supervise and be present at ISSC, or appoint a suitable substitute for weekly goal keeper training sessions of Broken Arrow Soccer Club registered players on Mondays or as otherwise agreed upon by both parties.
 - Spring: 28 sessions / 60 minutes each. Start and end date to be determined by CLIENT.
 - Fall: 28 sessions / 60 minutes each. Start and end date to be determined by CLIENT.
- Provide the CLIENT a monthly invoice for all services including an accurate report consisting of:
 - The registered BASC player names and the BASC team they are affiliated with attending each training session.
 - The basic skills exercised during each training session.
 - Reasons for cancellation of any training session.
- Respond to requests for information from the CLIENT within five business days of receipt.
- Physical ability to stand and walk for long time periods and be able to demonstrate drills and exercises.
- Inform the CLIENT of general keeper training issues.
- Communicate with the CLIENT, BASC teams, and BASC players via telephone, emails, and meetings to promote training sessions or cancellations of any training sessions due to inclement weather.
- When requested, attend BASC board meetings to report to the executive board a summary of keeper training business and answer questions.

Equipment, tools, materials and supplies provided by the CLIENT:

- Dedicated location for keeper training with goal, netting and marked lines.
- Access to lighted fields during times when daylight expires prior to or during scheduled training times.

COMPENSATION SCHEDULE

Definitions:

Training Session: A period of time during which the Trainer instructs players registered with the CLIENT in the techniques and strategy of positional play.

- Each training session shall consist of a minimum of 60 minutes of activity once per week.
- Any other training as mutually agreed upon in advance, and in writing, by both parties.

Compensation Schedule:

The CLIENT shall compensate the CONTRACTOR according to the following schedule:
